CITY COUNCIL PROCEEDINGS

June 10, 2015

The City Council of the City of David City, Nebraska, met in open public session in the meeting room of the City Office, 557 N 4th Street, David City, Nebraska. The Public had been advised of the meeting by publication of notice in The Banner Press on June 4th, and an affidavit of the publisher is on file in the office of the City Clerk. The Mayor and members of the City Council acknowledged advance notice of the meeting by signing the Agenda which is a part of these minutes. The advance notice to the Public, Mayor, and Council members conveyed the availability of the agenda, which was kept continuously current in the office of the City Clerk and was available for public inspection during regular office hours. No new items were added to the agenda during the twenty-four hours immediately prior to the opening of the Council meeting.

Present for the meeting were: Mayor Alan Zavodny, Council President Gary Kroesing, Council members Kevin Hotovy, Thomas Kobus, Gary Smith, and John Vandenberg. Also

present were City Attorney Jim Egr, and Deputy City Clerk Tami Comte. Council member Mike Rogers arrived at 7:03 p.m.

Also present for the meeting were: Sheriff Marcus Siebken, Matt Rief of Olsson Associates, Janis Cameron, Lisa Buntgen, Roger Treat, Randy Janak, Barb Vogl, Dr. Victor Thoendel, Water Employee Kevin Betzen and David City Family Aquatic Center manager John Svec.

The meeting opened with the Pledge of Allegiance.

Mayor Zavodny informed the public of the "Open Meetings Act" posted on the east wall of the meeting room and asked people to silence their cell phones.

The minutes of the May 13, 2015 meeting of the Mayor and City Council were approved upon a motion by Council member Vandenberg and seconded by Council member Kobus. Voting AYE: Council members Vandenberg, Kroesing, Hotovy, Smith, and Kobus. Voting NAY: None. The motion carried. Council member Rogers was absent.

Mayor Zavodny asked for consideration of claims. Council member Smith made a motion to authorize the payment of claims and Council member Kobus seconded the motion. Voting AYE: Council members Hotovy, Kroesing, Vandenberg, Kobus, and Smith. The motion carried. Council member Rogers was absent.

Council member Mike Rogers arrived at 7:03 p.m.

David City Family Aquatic Center manager John Svec reported that they have 14 lifeguards and of those 14, three are new guards. He stated that they hired a Barbi Rasmussen as a new assistant manager. They have sold 140 memberships and are still selling them. In an effort to promote professionalism from the guards, Svec is having them wear a "uniform" t-shirt that says "David City Family Aquatic Center Lifeguard" on them.

Sheriff Marcus Siebken reported that there may be petitioners in the area collecting signatures to have the death penalty issue added to the ballot in the fall.

Council member Smith made a motion to accept the committee and officers reports as presented. Council member Kobus seconded the motion. Voting AYE: Council members Vandenberg, Kobus, Rogers, Hotovy, Smith, and Kroesing. Voting NAY: None. The motion carried.

Matt Rief, representing Olsson Associates was present to give an update concerning the airport water main extension. Matt Rief reported that the plans and specs are completed on the project. He stated if you remember the project starts on 11th Street by the cemetery and connects with a 12" main and heads south along 11th Street to the county road north of the airport and runs back to Highway 15 and from there runs south to the airport. So, it's a 12" line along the county road and then it's a 10" line back to the airport access road and then we have an alternate bid section, basically, to extend a 10" main in along the airport access road to the hangars, about 700'. So, there's about 1,100' of 10" main and about 5,800' of 12" main and then another 700' of 10" main for extension along the airport access road. Matt Rief said, "Right now we're sitting on a cost estimate of about \$550,000. We're ready to go to bid. So, that's what I'm coming here tonight to do. We're ready to go to bid on it. We can start advertising tomorrow, put it up on our site and then we'll advertise on June 18th and June 25th and have the bid opening on July 1st."

Mayor Zavodny asked how much of that will be the 700' extenstion?

Matt Rief stated that the 700' extension will be approximate 10% of the project. Matt Rief said, "That can be easily taken out the way the bid is set up but it should fulfill the requirements of Jared Storm and what he was asking for as far as fire flows. I know Craig came to three or four meetings and talked about it and this it was decided on this option to extend the water main instead of doing the booster pump."

Mayor Zavodny said, "Do you forsee any issues as we go forward?"

Matt Rief said, "I think that Craig has talked to Obrist to try to get them to bid. I know that contractor's are busy right now so hopefully, we get another bid. Right now it's been difficult to try to get two bidders on a project."

Water/Sewer employee Kevin Betzen stated that they are hoping to get a lower bid from Obrist because they are already here in town.

Matt Reif stated that they call bidders and encourage them to bid on the project. There's a lot of development work out there right now. This isn't the best time to bid a project. We have an end of November completion so if they don't have their books full for the year then it's a nice project to fill out the books.

Council member Hotovy made a motion to advertise for bids for the construction of the airport water main extension with a bid opening scheduled for 1:30 p.m. on July 1, 2015. Council member Smith seconded the motion. Voting AYE: Council members Kobus, Hotovy, Smith, Kroesing, Vandenberg and Rogers. Voting NAY: None. The motion carried.

Matt Rief, representing Olsson Associates, also gave an update concerning the 11th Street bridge. They have the plans completed on the box culvert. It's an 8' x 6' culvert, so it's 8' wide and 6' high, twin structure. So, there will be two boxes tied together. It does have additional capacity. We talked about that before – about 30%. We did check the elevations of those walk-out basements. I thought it might be close, so we double-checked. The run is going to be about three foot lower.

Matt Rief stated that Council member Smith brought up the kink in the road and they are not totally going to be able to get away from that. I think that we can make it a lot better. Matt Rief said, "If you look at the north end, where the houses are, the road is in the center of the section line. You go to the south toward Hildy Addition, that road is in the center of the right-ofway, the center of the box culvert is about ten feet off of the right-of-way. If you come down through there you can see that road starting to jog to the east already so you are about eight feet off at the end of the asphalt edge. So, when we looked at it if we wanted to redo the road to completely take the kink out of it and follow the center of the right-of-way, you would have had to rip up pavement, regrade things and you would have been disturbing the golf course. There's a lot of issues there. There's also something called prescriptive rights. The road has been there for a long time. That's where the right-of-way has been established. I'm not going to completely take it out, but from where the asphalt ends, we are going to do all of our widening for the box culvert to the west. I think it played out pretty good. We didn't have to have a lot of reconstruction, we're not affecting the golf course, we're not affecting the pavement and it's going to take some of that out of there because right now you've got a very narrow structure that's only about 18 feet wide."

Mayor Zavodny said, "That was going to be my question. What is that going to be able to do for us on that issue?"

Matt Rief said, "We're going to widen out that structure."

Mayor Zavodny said, "So, capacity should be fairly unlimited, right?"

Matt Rief said, "Yes, we're not going to have a guard rail up either. We are building shoulders and we're extending it out. We looked at that criteria too."

Council member Kroesing said, "You don't have to have a guard rail?"

Mayor Zavodny said, "Council member Kroesing raises a good question. You don't have to have a guard rail up?"

Matt Rief said, "We looked at national criteria. Which is more of an accepted national standard and we're okay."

Mayor Zavodny said, "So, if someone drives right off of it, that's just how it is."

Matt Rief said, "We have the acceptable shoulders on there. We're basically matching the shoulder on the east side of the road. We're going to extend the shoulder on the west side of the road about ten feet."

Mayor Zavodny said, "So, you're going to be wider than the actual road no matter what."

Matt Rief said, "Oh yeah. You're going to widen it out. You're about 24' to the edge on the east side and about 26' on the other. So, about 50' across."

Mayor Zavodny said, "And what about weight capacity?"

Matt Rief said, "It's designed for semi loads – Nebraska Dept. of Roads standards. So, the section is 24' – two 12' lengths, 24' of gravel and a 6 foot shoulder. We have an extension off of that for the box culvert. We met those standards. I was worried about the guard rail too. I double checked it because if there was an accident they'd be coming back on me too."

Mayor Zavodny said, "You talked to Sod and Jim on this and they're clear on the whole thing? Any concerns from them?"

Matt Rief said, "I went through it with Sod today and I missed Jim today. But, we talked a lot the last time. The structures on A Street will be twin C & P culverts, so two corrugated metal pipes. They will each be five feet in diameter. We're going to match the same capacity that there is today. We're going to add some additional capacity on the 11th Street one for the box structure. Right now that opening is 12' across and we'll open it up to 16' across. The cost estimate - we are between 90,000 - 100,000, which is what we had estimated."

Mayor Zavodny asked if the County was helping on this project.

Matt Rief said, "This is a City project. There is no County participation in the 11th Street box culvert. Do you want me to go out for bids with it?"

Mayor Zavodny said, "We can't do that without an agenda item."

Matt Rief said, "That's fine. It was more for discussion than anything else. I have to put together the final package anyway."

Mayor Zavodny said, "That will have to be on the July agenda."

It was decided to have advertising for bids on the City Council agenda in July.

Dr. Victor Thoendel was present to discuss an invoice that he was presenting for payment for the installation of a shut-off valve on his sprinkler line. The issue was discussed at the May 27, 2015 Committee of the Whole meeting where Interim City Administrator Joan Kovar stated that in the past the City had been responsible to the meter.

Council member Hotovy made a motion to pay the invoice to Arps Gravel & Concrete, Inc. for \$207.48. Council member Rogers seconded the motion. Voting AYE: Council members Rogers, Hotovy, Smith, Kobus, Kroesing and Vandenberg. Voting NAY: None. The motion carried.

Council member Hotovy introduced Resolution No. 11 – 2015 and moved for its passage and adoption. Council member Vandenberg seconded the motion. Voting AYE: Council members Kobus, Hotovy, Kroesing, Vandenberg, Rogers, and Smith. Voting NAY: None. The motion carried and Resolution No. 11 - 2015 was passed and adopted as follows:

RESOLUTION NO. 11 - 2015

WHEREAS, the Butler County Fair's Annual parade is scheduled for July 26, 2015, and

WHEREAS, the Butler County Parade Committee has requested that Highway 15 at the intersection of "L" Street and Highway 15 be closed from 3:30 p.m. to 7:00 p.m. so the parade can cross Highway 15, and

WHEREAS, the Mayor and Council acknowledge Revised Statutes Chapter 39-1359, Rights-of way; inviolate for state and Department of Roads purposes; temporary use for special events; conditions; notice; Political Subdivisions Tort Claims Act; applicable, which states:

- (1) The rights-of way acquired by the department shall be held inviolate for state highway and departmental purposes and no physical or functional encroachments, structures, or uses shall be permitted within such right-of-way limits, except by written consent of the department or as otherwise provided in subsections (2) and (3) of this section.
- (2) A temporary use of the state highway system, other than a freeway, by a city including full and partial lane closures, shall be allowed for special events, as designated by a city, under the following conditions:
- (a) The roadway is located within the official corporate limits or zoning jurisdiction of the city;
- (b) A city making use of the state highway system for a special event shall have the legal duty to protect the highway property from any damage that may occur arising out of the special event and the state shall not have any such duty during the time the city is in control of the property as specified in the notice provided pursuant to subsection (3) of this section, and
- (c) Any existing statutory or common law duty of the state to protect the public from damage, injury, or death shall become the duty of the city making use of the state highway system for the special event, and the state shall not have such statutory or common law duty during the time the city is in control of the property as specified in the notice provided pursuant to subsection (3) of this section, and

- (d) The city using the state highway system for a special event shall formally, by official governing body action, acknowledge that it accepts the duties set out in this subsection and, if a claim is made against the state, shall indemnify, defend, and hold harmless the state from all claims, demands, actions, damages, and liability, including reasonable attorney's fees, that may arise as a result of the special event.
- (3) If a city has met the requirements of subsection (2) of this section for holding a special event and has provided thirty days' advance written notice of the special event to the department, the city may proceed with its temporary use of the state highway system. The notice shall specify the date and time the city will assume control of the state highway property and relinquish control of such state highway property to the state.
- (4) The Political Subdivisions Tort Claims Act shall apply to any claim arising during the time specified in a notice provided by a political subdivision pursuant to subsection (3) of this section.

WHEREAS, the City of David City wishes to support this annual event, and

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DAVID CITY, NEBRASKA, that the City Clerk is hereby authorized to forward this resolution to the State of Nebraska Department of Roads for the closing of Highway 15 and "L" Street from 3:30 p.m. to 7:00 p.m. for the parade to be held on July 26, 2015 in David City, Nebraska.

Council member Hotovy introduced Resolution No. 12 – 2015 and moved for its passage and adoption. Council member Kroesing seconded the motion. Voting AYE: Council members Kobus, Hotovy, Kroesing, Vandenberg, Rogers, and Smith. Voting NAY: None. The motion carried and Resolution No. 12 - 2015 was passed and adopted as follows:

RESOLUTION #12 - 2005

WHEREAS, the Federal Disaster Mitigation Act of 2000 was signed in to law on October 30, 2000, placing new emphasis on state and local mitigation planning for natural hazards and requiring communities to adopt a hazard mitigation action plan to be eligible for pre-disaster and post-disaster federal funding for mitigation purposes; and

WHEREAS, a Multi-jurisdictional Hazard Mitigation Plan was prepared by Lower Platte North Natural Resources District, with assistance from JEO Consulting Group, Inc. of Lincoln, NE. which includes the jurisdiction of David City, Nebraska.

WHEREAS, the purpose of the mitigation plan was to lessen the effects of disasters by increasing the disaster resistance of the Natural Resources District and participating jurisdictions located within the planning boundary by identifying the hazards that affect the City of David City and prioritize mitigation strategies to reduce potential loss of life and property damage from those hazards, and

WHEREAS, FEMA regulations require documentation that the plan has been formally adopted by the governing body of David City, Nebraska, in the form of a resolution and further requesting approval of the plan at the Federal Level; and

NOW, THEREFORE, the governing body of the City of David City, Nebraska, does herewith adopt the Lower Platte North Natural Resources District Multi-Jurisdictional Hazard Mitigation Plan Update in its entirety; and

Deputy City Clerk Comte presented a Power Point slide show with pictures of the properties that were on the nuisance list. The Milda Gray property located at 897 N. 5th Street was discussed and it was determined that it was now in compliance.

The Larry Parmer property located at 1055 N. 7th Street was discussed. The Council asked for pictures of the rear yard.

Council member Kroesing made a motion to table consideration of the Larry Parmer property located at 1055 N. 7th Street, which was declared a nuisance and given until May 29, 2015 to have the property in compliance or the City would abate the nuisance and file the costs as a lien against the property to the July City Council meeting. Council member Vandenberg seconded the motion. Voting AYE: Council members Kroesing, Vandenberg, Hotovy, Rogers, Kobus and Smith. Voting NAY: None. The motion carried.

The Roger and Kathy Treat property located at 715 N. 4th Street was discussed. Council member Mike Rogers asked if he could eliminate some of the volunteer maple trees.

Mayor Zavodny stated that he had stopped at the Treat house several times and was unable to find Roger Treat at the house. Mayor Zavodny stated that he will meet with Roger Treat before the July Council meeting.

Council member Hotovy made a motion to table consideration of the Roger and Kathy Treat property located at 715 N. 4th Street, which was declared a nuisance and given until May 29, 2015 to have the property in compliance or the City would abate the nuisance and file the costs as a lien against the property to the July City Council meeting. Council member Smith seconded the motion. Voting AYE: Council members Kroesing, Vandenberg, Hotovy, Rogers, Kobus and Smith. Voting NAY: None. The motion carried.

The Barbara Vogl/Barb Palik properties were discussed. Randy Janak stated that he felt that he did everything that was asked of him.

Mayor Zavodny stated that he agreed but that they were going to continue to monitor the properties.

Council member Rogers made a motion to accept the Barbara Vogl/Barb Palik properties as in compliance at this time. Council member Smith seconded the motion. Voting AYE: Council members Rogers, Smith, Vandenberg, Kroesing, Hotovy and Kobus. Voting NAY: None. The motion carried.

Council member Smith made a motion to approve the request by Scott Samek for a fireworks permit to sell permissible fireworks at 375 Nebraska Street (Amigo's parking lot). Council member Kobus seconded the motion. Voting AYE: Council members Kobus, Kroesing, Vandenberg, Rogers, Hotovy and Smith. Voting NAY: None. The motion carried.

Seth Cada requested permission to hold a firework display at the football field for a wedding reception on August 15, 2015 at 10:00 p.m.

Park/Auditorium Supervisor Bill Buntgen stated that the problem with these requests is the cleanup. There is always debris everywhere.

Council member Hotovy stated that he was concerned about their insurance and they would like them to explain their layout for the fireworks.

Deputy Clerk Comte stated that she had explained to Seth Cada that they would want to see a Certificate of Insurance but that he had not provided one.

Council member Hotovy made a motion to table the request of Seth Cada to hold a firework display at the football field for a wedding reception on August 15, 2015 at 10:00 p.m. to the July City Council meeting. Council member Smith seconded the motion. Voting AYE: Council members Hotovy, Smith, Rogers, Kroesing, Kobus and Vandenberg. Voting NAY: None. The motion carried.

Mayor Zavodny stated that the next item on the agenda was the consideration of the appraisal of the David City Ball complex. Mayor Zavodny stated that the appraisal came in significantly lower than the dollar amount that they needed. Mayor Zavodny said, "From my standpoint what I think we need to do is just continue to participate the way that we have been with them. Actually, I've had a lot of people share opinions on this. We want to keep the ball program. It is a great asset to the community. I'm just not convinced that the City owning it is the way to go at this point, given all of our other budgetary considerations. They recognize that they need to do some fundraising too. They haven't been as aggressive about that as they've needed to be."

Council member Smith asked what would happen if they just decided to throw in the towel and walk away.

Council member Kroesing said, "Do you want the responsibility of owning this complex?"

Council member Smith said, "It wouldn't bother me a bit as long as they were operating it."

Council member Kroesing said, "Where are you going to get the money to buy this thing? That's my question. I want to know how we're going to pay for everything that we have on our table for just what we've talked about this year, with that water line going to the airport and all of the engineering for the downtown redevelopment. I haven't figured out where just two bills are coming from, let alone anything else."

Council member Smith said, "Well, if we keep giving it like we have been giving it, you're going to give it to them anyway."

Council member Kroesing said, "I don't buy that either."

Council member Rogers said, "I think that we need them to come in and discuss this with us. We need to know what their plans are for the future."

Council member Kobus said, "How many people are involved in this?"

Mayor Zavodny said, "There are hundreds of kids in the ball program."

Council member Rogers said, "And we need it for the kids."

Mayor Zavodny said, "It brings a lot of people to town for games and tournaments. I know we sometimes have parking problems and those kinds of things. I think there's a solution here but I don't think that's 100% the City buys the thing unless you long-term debt it which I'm really unhappy with. I'm unhappy where we are now with long-term debt. I think for this year we need to participate at a level we're comfortable with like we have the past few years. They need to do some fundraising and see where we are at."

Council member Kroesing said, "They told you last fall that their John Deere mower is going to hell in a hand basket and that will be the first thing that they will come to us about. It's a 6,000 to 8,000 mower."

Mayor Zavondy said, "The thing is with the park and recreation money we can fund the mower. Where they're going to have trouble is that we can't pay any people. We can't pay their umpires and groundskeepers. We can't participate in any of that. I'm at the position right now that we keep doing what we have been doing and call it good for now. I think they should be able to get through this year again just doing what we did. Maybe they won't be comfortable with that. I don't know. I know a few of those guys have mentioned that they are ready to hang it up. I hope it doesn't come to that. We need a plan and we don't have it right now."

Council member Rogers said, "Well, the \$12,500 that we give them for the maintenance of their field – I was told that they won't need that next year."

Mayor Zavodny said, "There might be one more year of that conditioner."

Council member Rogers said, "I think they have enough left."

Mayor Zavodny said, "I hadn't heard that. The rain took a toll on that also. Ok. Do you want to invite them to our July meeting and see where we're at."

Council member Rogers said, "They have to give us some kind of plan."

City Attorney Egr said, "The biggest problem with the appraisal is that they couldn't show them as making money. You can't value it as a going business because it doesn't make money."

Council member Kroesing said, "There used to be banners all the way around the fence. Those were all sponsors. What happened to all of those?"

Mayor Zavodny said, "Let's invite them to the July Council meeting with their business plan."

Council member Kroesing made a motion to purchase uniform t-shirts for the lifeguards at the swimming pool at a cost not to exceed \$200. Council member Rogers seconded the motion. Voting AYE: Council members Kroesing, Rogers, Hotovy, Kobus, Vandenberg and Smith. Voting NAY: None. The motion carried.

Mayor Zavodny asked the Council to begin thinking about the 2016-2017 budget and what they would consider as their priorities. Mayor Zavodny stated that he would like to "knock down" the long term debt.

There being no further business to come before the Council, Council member Kroesing made a motion to adjourn. Council member Rogers seconded the motion.
