## CITY COUNCIL PROCEEDINGS

August 28, 2012

The City Council of the City of David City, Nebraska, met in open public session in the Meeting room of the Hruksa Memorial Public Library, David City, Nebraska, at 6:30 p.m. on 28<sup>th</sup> of August, 2012. The Mayor and members of the City Council acknowledged advance notice of the meeting by signing the Agenda which is a part of these minutes. Voting AYE: Council members Kroesing, Rogers, Vandenberg and Smith. Voting NAY: Council members Scribner and Svoboda. The motion carried.

There being no further business to come before the Council, Council member Kroesing made a motion to adjourn. Council member Rogers seconded the motion. Voting AYE: Council members Kroesing, Vandenberg, Rogers, Svoboda, Smith and Scribner. Voting NAY: None. The motion carried and Mayor Zavodny declared the meeting adjourned at 8:10 p.m.
